<b>REGISTRATION / CHECK-IN / BRIEFING DATE</b>	Aug 29, 2023 <b>REGISTRATION REMINDER:</b> All anglers must register in person with B.A.S.S. Staff onsite. This will be the only registration period. See Rule No. 4. <b>You will be fined for being late.</b>
<b>WEDNESDAY ACTIVITIES LOCATION</b>	TBD
<b>OFFICIAL REGISTRATION / ON SITE CHECK-IN</b>	2:00 pm to 4:20 pm via Time slots. Time slots will be emailed during tournament week.
<b>TOURNAMENT BRIEFING</b>	Virtual - All Contestants must view.
<b>OFFICIAL PRACTICE DAYS</b>	August 27 - August 29 During official practice, competitors may only fish with other competitors per Rule 3ii.
<b>PRE -TOURNAMENT OFF-LIMITS</b>	August 20 – August 26
<b>TOURNAMENT WATERS</b>	Tournament waters will be Lake Powell and any canals and creeks connecting to Lake Powell. Only water open to ALL public fishing will be considered tournament waters. Any waters closed to public fishing will be closed to this tournament's contestants.
<b>FISHING LICENSE</b>	Arizona fishing license is required. Online: <a href="#">Arizona Fishing License</a> <b>Utah will be accepted</b>
<b>FISH LIMITS</b>	Pro-Angler: 5 fish / Co-Angler: 3 fish / Largemouth/Smallmouth/Spotted Bass 12" min

Balance deadline dates are the dates the balances are due. You will not receive any further notices on balance due. It is the anglers' responsibility to be sure payment is made by the deadline date.

**Deposits are non-refundable regardless of date of cancellation.** Any balance of the entry fee paid in excess of the deposit will be refunded only if notification is made to the B.A.S.S. Tournament Department prior to the balance deadline date. Anglers on waiting list should not pay balance until contacted by tournament department.
